'Cambridgeshire County Council streamlined highway contracts across four divisions into a single service'

Project Description	Cambridgeshire County Council undertook a procurement exercise to integrate the existing 18 highway contracts delivered through four divisions into a single service designed to provide a consistent county wide service, removing duplication and waste. This approach laid the foundations for a collaborative partnership but the chosen approach alone was not sufficient to create the working relationship required to deliver the high quality, customer focused service and financial savings required by the Council. A step change was required to address the issues outlined above and this came with a change in leadership from both sides of the partnership. Development of in house model for forecasting and investment modelling purposes
Outcomes and benefits	Our service is now integrated, including the supply chain, and a successful major review of one element of the service gave us confidence to move forward and replicate that success on other elements.
	Benefits included:
	 KPIs refocused to reflect customer outcomes. Cost reduction amounting to 6% of turnover during 2012. Moved to a new structure in 2012 resulting in 17 % reduction in personnel on the Council side. A similar exercise had previously been conducted with the Provider some months earlier to reduce personnel numbers to an optimum level.
